The Office of Vice-Principal of Research at the Royal Military College of Canada will hold an internal competition to allocate

- One Tier 1 Canada Research Chair, and
- Two Tier 2 Canada Research Chairs.

in the Faculty of Engineering and the Faculty of Science. In 2000, the Government of Canada created a permanent program to establish 2,285 research professorships — Canada Research Chairs — in eligible degree-granting institutions across the country. Chairholders aim to achieve research excellence in engineering and the natural sciences, health sciences, humanities, and social sciences. The CRCP stands at the centre of a national strategy to make Canada one of the world's top countries in research and development. It invests up to \$311 million per year to attract and retain a diverse cadre of world-class researchers, to reinforce academic research and training excellence in Canadian post-secondary institutions.

There are two types of Canada Research Chairs:

**Tier 1 Chairs** tenable for seven years and renewable once, are for outstanding researchers acknowledged by their peers as world leaders in their fields. For each Tier 1 Chair, the institution receives \$200,000 annually for seven years.

Tier 2 Chairs tenable for five years and renewable once, are for exceptional emerging researchers, acknowledged by their peers as having the potential to lead in their field. For each Tier 2 Chair, the institution receives \$100,000 annually for five years, with an additional \$20,000 annual research stipend for first-term Tier 2 Chairs.

An "emerging researcher" is one who has been an active researcher in their field for fewer than 10 years at the time of nomination. Justified career breaks due to factors including parental leave, medical leave, COVID-19 closures, or familial obligations can significantly extend the eligibility period. Life circumstances such as illness, disability, family and community responsibilities affect emerging and established researchers alike. Such circumstances are expected to impact a candidate's record of research achievement and will be taken into careful consideration during the assessment process.

## **Institutional eligibility requirements:**

Applicants must hold a regular professorship at the Faculty of Engineering or the Faculty of Science to be eligible for this competition.

## **Application package:**

The documentation to be submitted must include the following:

- A curriculum vitae
  - o include all career interruptions, if applicable;
- A description of the research program (maximum four pages) in NSERC format, including the following elements:
  - o A summary stating the objectives of the research program;
  - Context and background;
  - Methodology;
  - o Participation of research users and dissemination of results;
  - o Description of the proposed training strategies for highly qualified personnel (HQP).
